**ORDINANCE NO. 2017-11-164**

**AN ORDINANCE AMENDING APPENDIX A, ARTICLE A8.000 OF THE CODE OF ORDINANCES, CITY OF SAN ANGELO TEXAS, BY AMENDING SECTION A8.008 "WATER, SEWER AND TRASH DEPOSITS", PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE**

**BE IT ORDAINED BY THE CITY OF SAN ANGELO:**

1) **THAT**, Appendix A, Article A8.000 of the Code of Ordinances, City of San Angelo, Texas, Section A8.008, "Water, sewer, and trash service deposits", is hereby amended as follows:

**"Sec. A8.008 Water, sewer and trash service deposits**

(a) Water service. Each and every water meter shall require the following minimum cash

\*The amounts shown for commercial deposits shall be the minimum allowed. The actual deposit will be determined by the water utility department based on similar types of uses.

(b) Sewer service. Each and every customer establishing sewer service without water service, whether with or without trash service, shall make a minimum cash deposit with the water department of the following amount:

- (1) Residential: \$50.00.
- (2) Commercial: \$100.00.

(c) Trash service. Each and every customer establishing trash service without water or sewer service shall make a minimum cash deposit with the water department of the following amount:

- (1) Residential: \$50.00.
- (2) Commercial: \$100.00.

(d) Waiver.

- (1) Residential customers may request a waiver of the deposit requirement.
- (2) A waiver will be granted upon:

- ~~(A) Payment of a ten dollar (\$10.00) credit check processing fee;~~
- ~~(B) Receipt by the city of a credit report indicating no record of delinquencies or late payments; and~~
- ~~(C) Confirmation of a history of no delinquencies on the requestor's prior or active accounts with the water utilities department.~~

(e) Interest. All cash utility deposits made prior to October 1, 2004, shall accrue simple interest at the annual rate of four percent (4%) until September 30, 2004. No deposit shall accrue any interest nor shall any interest amount be paid on amounts on deposit after September 30, 2004."

**2) THAT,** the following severability clause is hereby adopted with this amendment:

SEVERABILITY:

That the terms and provisions of this Ordinance shall be deemed to be severable in that if any portion of this Ordinance shall be declared to be invalid, the same shall not affect the validity of the other provisions of this Ordinance.

**3) THAT,** this Ordinance shall be effective on, from and after the 1<sup>st</sup> day of January 2018.
