

Inspector comments continued:

- * Row I - (Cage 1-12) - professional plumber has determined that drains are compromised which is effecting the ability of kennel attendants to clean cages. There has been snaking of the pipes which will work on a short-term basis. Please review options.
- * Dog Kennels: need filters changed on A/C units. A/C unit in the front of the building which is where offices and city employees work is out. Please remedy ASAP.
- * Very concerned about the number of animals versus cages. EX# 12 if you have a hoarding situation where you go to court for animal cruelty where would you house the animals
- * Noise is a major issue ... concerned about dogs and people, way too loud.
- * Very happy to see an organize unit of employees determined to meet and expanded the standards of the Texas State Health Statues.
