### III. Regular Agenda:

### a. RCC15-09: Kinney Franke Architects

**Subject:** A request for approval of a remodel to the exterior of an existing building (Judge Edd B. Keyes Building) in the River Corridor, as required by Section 12.703(b)(2) of the River Corridor Development Ordinance, including removal of a portion of an existing building façade, a new entry trellis, polycarbonate paneling, new windows, door frames, and signage on the following property:

**Location**: 119 and 113 West Beauregard Avenue; generally located approximately 110 feet west of the intersection of South Irving Street and West Beauregard Avenue; and specifically occupying the San Angelo Addition, Block 9, Lots 4-8 and 13-18, and the north 110 feet of the west 37.5 feet of Lot 18, in San Angelo, Texas.

## b. CA15-02 The Bosque

**Subject**: A request for approval of a Certificate of Appropriateness, as required per Section 211.E of the Zoning Ordinance, for a 400-square foot concession building, food trucks, outdoor seating with tables, a new 18-hole miniature golf course, and an attached, lit, wall sign, on the existing City of San Angelo public recreational area, "The Bosque," on the following property:

**Location:** 330 South Irving Street; generally located between South Irving Street and North Chadbourne Street; and specifically occupying lots 4 thru 31, Block B, in the O.B. Sampson Subdivision.

#### c. RCC15-08 The Bosque

**Subject:** A request for approval of a 400-square foot concession building, food trucks, outdoor seating with tables, a new 18-hole miniature golf course, and an attached, lit, wall sign on the existing City of San Angelo public recreational area, "The Bosque" as required per Section 12.703(b)(1) of the River Corridor Development Ordinance, on the following property:

**Location:** 330 South Irving Street; generally located between South Irving Street and North Chadbourne Street; and specifically occupying lots 4 thru 31, Block B, in the O.B. Sampson Subdivision.

## d. RCC15-07: Hilton Harris

**Subject:** A request for approval for a remodeling to the exterior of an existing building in the River Corridor as required per Section 12.06.003(a) of the River Corridor Development Ordinance including 1) the painting of brick walls, 2) the painting of metal casings around the windows and doors on the front façade, 3) other façade improvements and 4) the removal of all text from an existing sign, on the following property:

**Location:** 109 South Chadbourne Street; generally located at the southwest corner of Beauregard Avenue and Chadbourne Street; and specifically occupying the North 50
