## THE CITY OF SAN ANGELO, TEXAS MINUTE RECORD OF A REGULAR MEETING OF THE PARKS & RECREATION ADVISORY BOARD

## I. OPEN SESSION (3:30 p.m.)

## II. CONSENT AGENDA

1. Consideration of approving the February 26, 2015 meeting minutes.

Ms. Cross made a motion to approve the meeting minutes. Ms. Palos seconded the motion which passed unanimously.

## III. REGULAR AGENDA: PUBLIC HEARING AND COMMENT

2. Consideration of adding two "Little Free Library" sites one at Kirby Park and one at Unidad Park.

Mr. White presented background information on this item. The program was started by Angelo State University Honors Students. There have been Facebook and email requests to add more libraries. A local family would like to build and maintain one on the North side of town at Kirby Park and the second one would be installed at Unidad Park. Mr. Perez made a motion to approve the installation of two "Little Free Library" stations to be installed at Kirby Park and Unidad Park as presented. Mr. Palos seconded the motion which passed unanimously.

3. Updates on an awning for Kids' Kingdom playground, Eggemeyer Lease and Recreation Manager vacancy and consideration of approving any matters related thereto.

Recreation Manager - We received seventy applications for the Recreation Manager position and have narrowed it down to five interviews. Interviews will be scheduled for April and we hope to have the position filled in late May.

Eggemeyer Lease - A memo was sent to Council on the Eggemeyer Lease. Two Council members requested additional information and one requested a meeting. Improvements to the property are continuing. Future lease of this park property will need to follow a legal process similar to the recent process followed to lease lake park property. If the lease is renegotiated it will not be like the original lease.

Awning for Kids' Kingdom Playground - Deputy Superintendent presented pricing information for covering different areas of the playground. The Board discussed the cost and need for covering not only Kids' Kingdom but other parks that have less shading. A copy of the pricing is attached as a part of the permanent record.

Future items are an update on the PONY league, the Dog Park, and information on a girl's softball league.
