4. Update on major projects: The Bosque expansion, dog park, Red Arroyo Trail and boat ramps.

An agreement to build a concession and miniature golf course in the Bosque area will go to Council for consideration in May. Still under consideration for the east area is a possible gazebo for weddings. The fund raising for the dog park has reached about \$60,000 and a "go fund me" account has been set up for additional fundraising. The Red Arroyo project has been delayed due to rains moving completion back to late fall. Some concrete has been poured, trail heads a retention pond and some trails. Once funding for the for the dog park is complete the Board will be asked for their final recommendations on the location of the park. We have received a grant from the State for a boat ramp at the lake. We are waiting for permits from the Corps of Engineers since the old permit has expired.

5. Update on hiring of a new Recreation Manager.

Mr. White gave some background information on the new Recreation Manager. Mr. Casey is retired from the Air Force and has experience in running the Athletics Program at Goodfellow Air Force Base.

The Board discussed the terms of members. Mr. Campbell made a motion to nominate Mr. Louis Perez as Chair for the Board. Mr. Barnhart seconded the motion which passed unanimously. Mr. Barnhart made a motion to nominate Mr. Mike Campbell as Vice-Char. Ms. Palos seconded the motion which passed unanimously.

Future items are an update on the PONY league, a shade structure for Kids' Kingdom, the Dog Park, and information on a girl's softball league.
