

**THE CITY OF SAN ANGELO, TEXAS
MINUTE RECORD OF A REGULAR MEETING OF THE
PARKS & RECREATION ADVISORY BOARD**

Following notice and publication, the Parks & Recreation Advisory Board convened in a regular meeting at 3:30 p.m. July 23, 2015 in the South Meeting Room, McNease Convention Center, 501 Rio Concho Dr, San Angelo, Texas.

Board members present were Mr. Louis Perez, Mr. Donald Barnhart, Ms. Gloria Henderson, Mr. Mike Campbell, Mr. Francis Jelensperger, Ms. Debbie Cross and Ms. Mary Palos.

Staff members present were Mr. Carl White, Mr. Brent Casey and minutes were recorded by Mrs. Ida Rios.

I. OPEN SESSION (3:30 p.m.)

A. Call to Order

Mr. Perez called the meeting to order at 3:30 p.m.

B. Public Comment

II. CONSENT AGENDA

1. Consideration of approving the June 25, 2015 meeting minutes.

Mr. Barnhart made a motion to approve the meeting minutes. Ms. Henderson seconded the motion which passed unanimously.

III. REGULAR AGENDA: PUBLIC HEARING AND COMMENT

2. Consideration of recommending approval of a proposal to develop an "Old West Town" in Bart DeWitt Park.

Mr. White presented background information and introduced Mr. Jack Smith with the Concho Cowboy Company. They are a reenactment group looking for a home in San Angelo. The reenactment group would like to have an "Old West Town" built on the east side of the Oakes Street Bridge. It could be store front facades with a saloon and restrooms. The cost is estimated at about \$600,000. The Company could lease the area and host gun fights and other events. The Board discussed continuing membership and projects by the Company. The Board also discussed other functions at the area, rentals, concessions and special events. Mr. Barnhart made a motion to recommend the plan, to build "Old Santa Angela", as presented conceptually and proceed to City Council for consideration. Ms. Henderson seconded the motion which passed unanimously.

3. Discussion of athletic practice field rental and reservation policies and approval of any matters related thereto.

Mr. Brent Casey presented to the Board information on field rental prices and policies for both Texas Bank Sports Complex and public parks.

4. Update on major projects, events and activities: paddle board and kayak rental proposal, additional restrooms at the Texas Bank Sports Complex, Bosque improvements, summer camps, track meet and pool.


Mr. White presented reports to the Board on current projects. A copy of the report is included as a part of the permanent record.

5. Consideration of future agenda items.

Future items to discuss will be identification signs at parks and additional information on field reservations.

Ms. Henderson made a motion to adjourn, seconded by Ms. Palos. The meeting was adjourned at 4:35 p.m.
