a. Consideration and approval of the January 21, 2016, Design & Historic Review Commission meeting minutes.

III. Regular Agenda:

a. RCC15-33: Brooks

Subject: A request for approval, as required by Section 12.06.003(b)(2) of the River Corridor Development Ordinance, of a remodeling of the exterior of an existing building for the following improvements: 1) removal of metal siding and the installation of five new double doors with flanking windows and transoms on the northern façade; 2) replacement of two windows with a new garage door entrance and the infill of an existing loading door entrance with brick on the western façade; and 3) infill of all existing lower-level windows with brick, and the removal and replacement of the existing landing and loading door with a wheelchair accessible ramp and emergency door on the southern façade, located at the southeast corner of West Twohig Avenue and South Randolph Street, on 0.436 acres.

b. RCC15-34: Curtis Sign Co.

Subject: A request for approval, as required by Section 12.06.003(b)(1) of the River Corridor Development Ordinance, for a new 32-square foot, illuminated freestanding sign with changing LED display, located at the southeast corner of North Oakes Street and East 3rd Street, on 5.46 acres.

c. RCC16-02: San Angelo Medical Center

Subject: A request for approval, as required by Section 12.06.003(e)(4) of the River Corridor Development Ordinance, for a 192-square foot illuminated freestanding sign that includes a new 96-square foot LED message display board, located along the east side of North Bryant Boulevard, south of the Houston Harte Expressway (U.S. 67), on 0.95 acres.
