Policies for Use of Inflatable Play Equipment on City Parks

(May 2016)

General: You are welcome to use inflatable jumps at the pre-approved designated locations. **Only inflatable jump vendors who meet insurance requirements and have been pre-approved by the Parks & Recreation Department will be allowed to operate in the parks.** Please contact us for a current list of pre-approved vendors at 325-657-4279 or at Santa Fe Crossing at 702 S. Chadbourne. Maps of City of San Angelo Parks are available at the Parks and Recreation Administrative office at Santa Fe Crossing or can be found on-line at the City of San Angelo’s website at www.cosatx.us.

This policy does not include large community events such as the Children’s Fair. These events are covered by a Special Event permit application process and are approved on a case by case basis by City personnel. The exact placement of the equipment must be specified by the Parks and Recreation Department.

General definition of inflatable play equipment – Inflatable play equipment is any soft bouncing unit constructed out of heavy-duty vinyl. They are laid out like a tent on the ground, and form into a soft bouncing area with walls when they are filled with a continual flow of air. This equipment is provided by vendors to renters, usually for a fee.

Parks at which Inflatable Play Equipment May be Used:

Approved vendors will place in specifically pre-approved locations only.

- Firefighter’s Memorial City Park
- Kids’ Kingdom Park
- Unidad (College Hills) Park
- Glenmore Park
- Producers Park

General Restrictions for Use of Inflatable Play Equipment:

- Only inflatable companies listed with the City of San Angelo as an approved vendor and with a current certificate of insurance on file may be used.
- Inflatable play equipment rental companies must be pre-approved by the Parks & Recreation Department to be permitted to use their equipment on any park. There is no fee for this.
- **The party making the reservation must come by the Parks & Recreation Department, at 702 S. Chadbourne St., to pick up their reservation confirmation form. This must be done during the hours of 8 a.m. to 5:00 p.m., Monday through Friday.**
- Groups and vendors wishing to use inflatable play equipment must place this equipment on park grounds such that the safety of the children is ensured and in compliance with the restrictions noted in this policy.
- City of San Angelo Code of Ordinance, Article 9.200, Sec. 9.204 Traffic (5) states that **it is a violation to drive any vehicle onto any park property.** The Parks & Recreation Department requires that inflatable play equipment must be hand carried, or hand trucked into and out of parks property.
- The Parks & Recreation Department prohibits any play equipment with water slides on any park property, due to excessive wear by the water and foot traffic on parks grounds.
- **Approved vendors are required to secure the inflatable play equipment with stakes in the pre-approved areas designated by the Parks & Recreation Department.**
- **Any electricity at the parks may not be used to operate the inflatable play equipment.** Vendors must use their own power source in the form of an electrical generator. This equipment may not be fueled on the park turf areas. It is permissible to fuel this equipment on the park parking areas.

I have read and will abide by the policy concerning the use inflatable play equipment. It is my responsibility to inform all members of my party, including those professionally employed on the rules of the grounds.
