- II. Consent Agenda:

a. Consideration and approval of the June 16, 2016, Design & Historic Review Commission meeting minutes.

III. Regular Agenda:

a. RCC16-14 Mazur

Subject: A request for approval, as required per Section 12.06.003(b)(1) and 12.06.003(b)(2) of the River Corridor Development Ordinance, for the following: (1) reconstruction of exterior brick facades on the north, east, and west elevations, painted a dark grey matte color; (2) installation of new wood doors and glass windows and painting of all wood trim, window trim, doors, and garage doors a black color; (3) installation of exterior wall sconce lights; (4) construction of new metal canopies, with lighting, along portions of the north, east, and west building facades, painted a black color; and (5) construction of a 416-square foot outdoor patio, on property generally located at the southeast corner of South Chadbourne Street and East College Avenue, and consisting of approximately 0.19 acres.

b. RCC16-15 Crockett National Bank

Subject: A request for approval, as required by Section 12.04.017 (3) and Section 12.06.003.b.2 of the River Corridor Development Ordinance, for the following modifications on two buildings: 1) replace existing wall signage with 148-square foot and 200-square foot illuminated signs on the south and west elevations, respectively, at 502 South Koenigheim Street; 2) replace glass doors at north and south entrances, change the bronze colored frames to black frames, install new lighting fixtures, and tile the recessed entrance way at 502 South Koenigheim Street; and 3) replace existing wall signage with a 100-square foot illuminated sign and replace an existing 96-square foot / 31-foot high, monument sign with a 95-square foot / 28-foot high, monument sign, on property generally located on the northeast and southwest of the intersection of North Koenigheim Street and West Avenue B, and consisting of approximately 2.547 acres.

c. RCC16-16 Marshall

Subject: A request for approval, as required by Section 12.06.003(e)(4) of the River Corridor Development Ordinance, for a new 27-square foot illuminated projecting sign along the front building elevation of an existing commercial building located at 19 East Concho Avenue, on property generally located along the south side of East Concho Avenue, between South Chadbourne and South Oakes Streets, and consisting of approximately 0.218 acres.

d. RCC16-18 Fast Signs

Subject: A request for approval, as required by Section 12.06.003(e)(4) of the River Corridor Development Ordinance, for a new 39-square foot illuminated wall sign along the side building elevation of an existing office building located at 201 West Twohig Avenue, on property generally located at the west-

southwest corner of West Twohig Avenue and South Randolph Street, and consisting of approximately 0.44 acres.
