2412 N. Chadbourne/Skyway Motel

Funding Requested: \$18,750

**Match:** \$6,250 (25%)

Total Project Cost: \$25,000

**Summary of Work:** Removing the existing concrete and asphalt, adding base materials and laying new asphalt for the parking lot as well as landscaping that would

include a new sprinkler system, grass and bushes around the complex.

Project Criteria: Meets 5 of the 14

Staff recommendations: include more landscaping and extend sidewalk to street additional 6 feet. Staff also requested increase in funding for additional improvements to be made.

Motion by Jason Fernandez to approve and also increase budget up to \$1,000 contingent upon 25% from landowner per TIRZ policy to complete staff recommended projects, seconded by Lee Pfluger – motion carried unanimously with Casey Barrett abstaining.
