- IV. **ZBA19-02: Lancaster** **SMD#1—Tommy Hiebert**

A request for approval of a Variance from Section 501.A of the Zoning Ordinance to allow for a 3 foot side yard setback in lieu of the required 5 feet for a House within the Single Family Residential (RS-1) Zoning District located at 2250 Joy Road.

- V. **ZBA 19-03: Wells** **SMD#5 – Lane Carter**

A request for approval for the following variances to allow additions to a single-family dwelling: (a) a variance from Section 501.A of the Zoning Ordinance to allow a 16-foot front yard setback from South Tyler Street in lieu of the required 25 feet; (b) a variance from Section 501.A of the Zoning Ordinance to allow a 0-foot front yard setback from South Taylor Street in lieu of the required 25 feet; and, (c) a variance from Section 511.B of the Zoning Ordinance to allow one parking space in lieu of the required two parking spaces for a single-family dwelling, located at 1441 South Tyler Street.

VI. Consideration and possible action regarding adoption of restated by-laws of the Zoning Board of Adjustment.

With the passage in October, 2018 of an ordinance amending the Code of Ordinances for the City of San Angelo Art. 2.07 "Boards, Committees and Commissions," Organization and Procedures along with Division 3. Zoning Board of Adjustment of the City of San Angelo, the restated by-laws for the Zoning Board of Adjustment are presented for consideration.
