A request for approval of a variance from Section 501.A of the Zoning Ordinance to allow for a front yard setback of 18 feet in lieu of the required 25-foot; a variance Section 501.A of the Zoning Ordinance to allow for a rear yard setback of 6 feet in lieu of the required 20 feet; and a variance Section 509.B.3.a of the Zoning Ordinance to allow the existing privacy fence located in the front yard to maintain a height of 6 feet in lieu of the maximum 4 feet for a single-family dwelling within the Single Family Residential (RS-1) Zoning District located at 319 South Cecil Street.
