## I. Call to order; Establishment of quorum

The meeting was called to order at 10:07 AM by Chair McLaughlin. A quorum of five (5) was present.

#### II. Consent Agenda

a. Consideration and approval of the December 12, 2019, Design & Historic Review Commission meeting minutes.

Commissioner James made a Motion to APPROVE the consent agenda; Commissioner Engdahl seconded the Motion. The Motion passed unanimously, 5-0.

#### III. Election of Chair and Vice-Chair

Commissioner Thomas made the Motion to appoint Stephen McLaughlin for Chair; Commissioner Engdahl seconded the Motion. The Motion passed unanimously, 5-0. Commissioner James made the Motion to appoint Lisa Wallace for Vice-Chair; Commissioner Thomas second the Motion. The Motion passed unanimously, 5-0.

### IV. Regular Agenda

a. DD20-01: Box Hangar Two Ten — A request for Downtown District approval of an exterior remodel for a property located at 19 West Beauregard Avenue.

Shelly Paschal, Planner, introduced herself and provided a brief synopsis of the case. Mrs. Paschal indicated the project's location, elaborated on details regarding the proposal, and showed the subject property. Mrs. Paschal concluded her presentation with a recommendation of approval along with the basis for her recommendation, subject to three conditions.

Chair McLaughlin opened the meeting for public comment.

Mr. David Alexander, applicant, came forward stating that he plans to occupy the upstairs and lease out the first floor of the building.

Chair McLaughlin closed public comment.

Commissioner James made a Motion to APPROVE case DD20-01 as presented with conditions. Commissioner Schmidt seconded the Motion. The Motion passed unanimously, 5-0.

b. RC20-01: Watkins — A request for River Corridor approval of a 71.5-square foot illuminated freestanding sign, a 32-square foot illuminated wall sign, and exterior wall lighting for a property located at 909 West Beauregard Avenue.

Jeff Fisher, Principal Planner, introduced himself and provided a brief synopsis of the case. Mr. Fisher indicated the project's location, elaborated on details regarding the proposal, and showed the subject property. Mr. Fisher concluded his presentation with a recommendation of approval along with the basis for his recommendation, subject to three conditions.

c. CA20-01: Fort Concho — A request for approval of a Certificate of Appropriateness for the placement of a temporary sign to promote Fort Concho events, generally located at 702 South Oakes Street.

Mrs. Paschal indicated the project's location, elaborated on details regarding the proposal, and showed the subject property. Mrs. Paschal concluded her presentation with a recommendation of approval along with the basis for her recommendation, subject to two conditions.

Mrs. Paschal indicated the project's location, elaborated on details regarding the proposal, and showed the subject property. Mrs. Paschal concluded her presentation with a recommendation of approval along with the basis for her recommendation, subject to two conditions.
