Q&As

Q: Please provide the model numbers from the projector and the name and model number off the amplifier.

A: The projector is an Epson Powerlite 1980WU. We don't own an amplifier from the room, that will be something the approved vendor will need to supply. We have a Sound Mixer, Yamaha TF-1, but we do not have any amps for the room.

Q: Where are the connections for the projector and what type of connections currently exist? (HDMI/VGA/Etc).

There are connections in both the front and back of the room. HDMI and VGA.

Q: For the Interactive Display requested, is this intended to be an ability to overlay content feeding projector or standalone interactive display?

A: The display we are requesting is to display PowerPoint presentations that are being presented at meetings. The presentations need to display on the projector screen in the room, the display that is on the ground (which we do not have and are requesting) and then also looped into the broadcast. The projector screen is for the viewing public in the room. The display on the ground will be for the board members. We are thinking of having the display located in front of the podium.

Q: Is there a wiring path to the basement for a link to the PEG channel?

Yes

Q: Do you want the cameras permanently installed on the walls or use movable stands for them?

A: Cameras need to be permanently installed on the wall.

Q: Are there extra network drops in either room that could be used by this system?

A: Yes. Cable type is Category 6 Ethernet.

Q: Where do you want to store the microphones when not in use (control room space or in the East Mezzanine?)

A: We will store the microphones in the room next door which will also serve as our control room.

Q: Is a desk available in the proposed control room or should furniture be included?

A: We do have a desk that we can use. It is not very large, so it would just depend on how much equipment will be set on it.

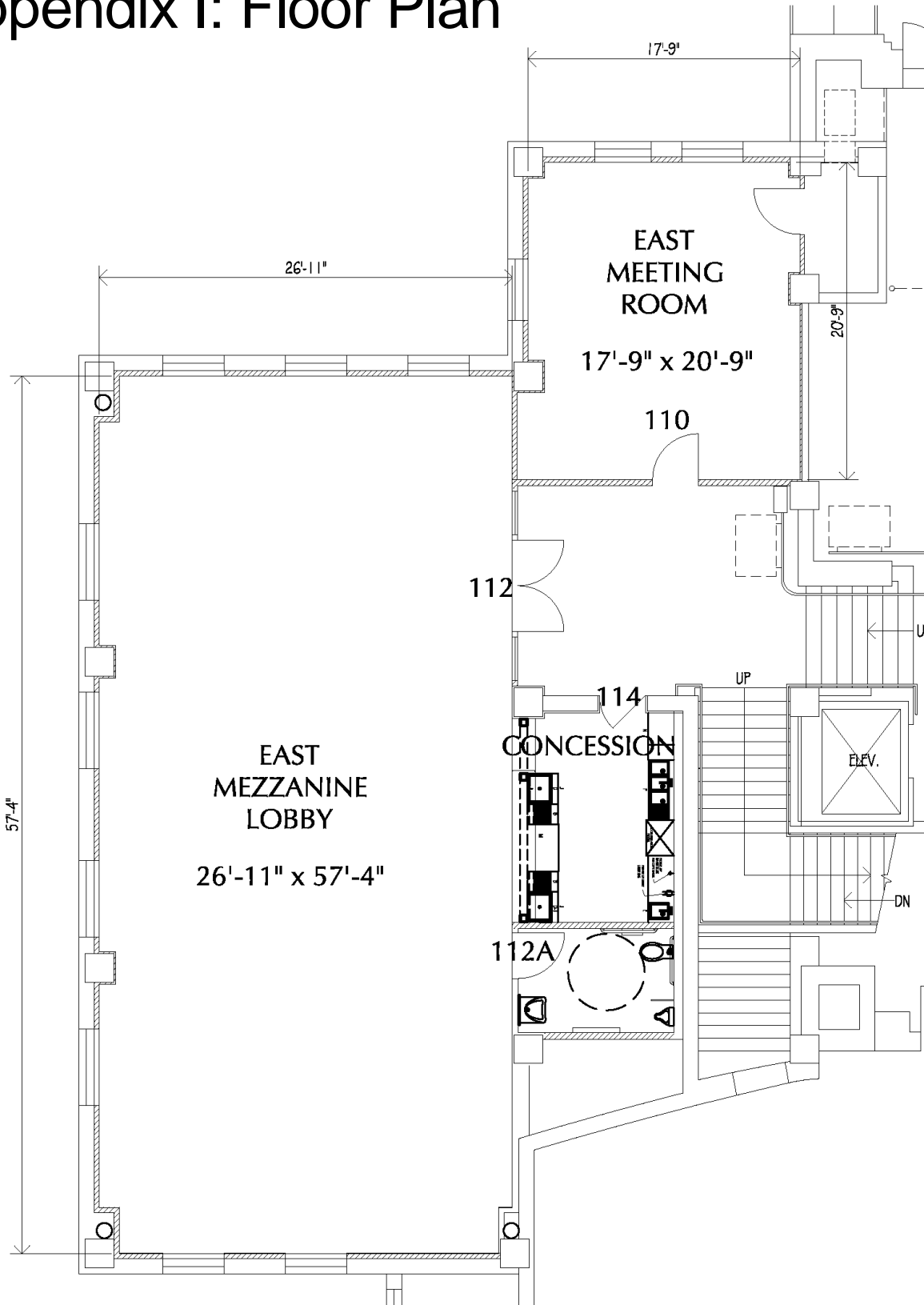
