FIRE PREVENTION FEES

Operational permits are required for various processes. The fee schedule below lists the various operational permit fees which include a review of the operation and associated processing fees. These fees are for permits only and do not include related inspection fees. All inspection fees are \$25.00 unless specified by the particular operation.

What is a Fire Code Compliance Fee and what does it include? A Fire Code Compliance Fee is utilized for new or existing construction or renovation projects. The purpose of the fee is to cover associated plan review costs, consultations, permit processing and the final inspection when the work is completed.

These fees are effective as of April 19, 2016

If a facility of an operation qualifies for a facility or an operation fee under more than one category listed below, then the highest fee will be assessed. Inspection fees will not be cumulative for a single inspection.
