

**CITY OF SAN ANGELO, TX**  
**Paperless, AutoPay, Online Registration Sweepstakes**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES.** Purchase will not increase your chances to win. Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Invoice Cloud, Inc. **Eligibility:** Sweepstakes is open to legal U.S. residents from January 18, 2021 to April 18, 2021. Two (2) winners will be chosen at random at the conclusion of the sweepstakes period. The Invoice Cloud service website's database clock will be the official timekeeper for the Sweepstakes. Internet entry must be made by the entrant, only at the City of San Angelo, TX customer self-service portal.

**\*\*Customers who previously signed up for Paperless billing, AutoPay, or registered to pay online and continue their enrollment through April 18, 2021 will be automatically entered.**

If you would like to be entered in the sweepstakes but not sign up to Go Paperless with e-Bills on the City of San Angelo, TX customer self-service payment portal, you may do so by sending a 3x5 card with the hand printed words: City of San Angelo, TX Sweepstakes, your name, address, telephone number, and the bill account number for which you are entering.
