To the registered voters of the City of San Angelo, Texas:

Notice is hereby given that the polling places listed below will be open from 7:00 a.m. to 7:00 p.m., on Saturday May 6, 2023 for voting in a general election to elect Council Members for Single Member District One, Single Member District Three, and Single Member District Five for four-year terms; and a special election for the adoption or rejection of certain propositions each providing for amendment to the Home Rule Charter of the City of San Angelo.


