#### B. **Z23-02: 402 N Bryant Blvd (SMD#3)**

A request for approval of a rezoning from the Light Manufacturing (ML) Zoning District to the General Commercial (CG) Zoning District, being 0.951 acres, located at 402 N. Bryant, at the northeast intersection of W. 4th St. and N. Bryant.

## C. ROW Abandonment – 100-300 E 4th Street (SMD#4)

A request to abandon the approximately 20'x507' (unimproved) alleys in Blocks 39 and 40, Miles Addition, between 4th and 5th Street and N. Oakes, N. Magdalen and Pecan Streets.
