The purpose of the meeting will be to discuss and resolve the Civil Service Commission topics appearing on the agenda as follows:

1. Call to order.
2. Approval of the minutes of the previous meeting.
3. Approval of the daily action log.
4. Recognition of the Board renewal for Raul Lopez to his tenth term.
5. Election of chairman and vice-chairman.
6. Discussion of Local Government Code 143, Section 143.006, IMPLEMENTATION: COMMISSION, subsection E as it applies to Civil Service Rules & Regulations Local Code 143, Section 12, subsection E to determine if a January meeting is preferred in order to elect a chairman and vice-chairman or continue to meet as needed and hold such election during the first meeting of the calendar year.
7. Discussion and guidance related to rescheduling the Assistant Chief (Fire Department) exam due to cancellation/postponement on January 14, 2022.
8. Discussion and consideration of revising Civil Service Rules Local Code 143, Section 48 "Postponement or Cancellation of Examination" to include authorizing the Civil Service Director to act; clarifying who can test in the event there are not a sufficient number of competitive participants; authorizing the Chief to change the study materials and modifying the notice of sources requirement.
9. Discussion of Local Government Code 143, Section 143.032, PROMOTIONAL EXAMINATION PROCEDURE, subsection A as it applies to Civil Service Rules & Regulations Local Code 143, Section 46 "Promotions – Filling Vacancies", subsection E, 5.
10. Discussion and consideration of revising Civil Service Rules Local Code 143, Section 45 "Content of Examination" subsection I to include a psychological exam for the fire department as well as police department.
