The purpose of the meeting will be to discuss and resolve the Civil Service Commission topics appearing on the agenda as follows: Call to order.

- 1. Approval of the minutes of the previous meeting.
- 2. Approval of the daily action log.
- 3. Discussion of Local Government Code 143, Section 143.030, ELIGIBILITY FOR FIRE DEPARTMENT PROMOTIONAL EXAMINATION, subsection B and C, and consideration of revising applicable Civil Service Rules & Regulations, Section 46 "Promotions Filling Vacancies" subsection B, 6, to clarify testing eligibility when a classification has both a tested and appointed position.
- 4. Discussion and consideration of revising Civil Service Rules & Regulations, Section 48 "Postponement or Cancellation of Examination" to include authorizing the Civil Service Director to act; clarifying action needed when postponement or cancellation occurs; authorizing the Chief to change the study materials and modifying the notice of sources requirement.
- 5. Discussion and consideration of revising Civil Service Rules & Regulations, Section 46 "Promotions Filling Vacancies", subsection E, 5, to amend the number of participants required to make a promotional examination competitive.
- 6. Discussion of Local Government Code 143, Section 143.027, PROBATIONARY PERIOD, subsection A, and consideration of revising applicable Civil Service Rules & Regulations, Section 70 "Probation Period", to modify the probationary period for the Police Department in accordance with Local Government Code 143, Section 143.027.
- 7. Discussion of Local Government Code 143, Section 143.022, PHYSICAL REQUIREMENTS AND EXAMINATIONS, subsection B, and consideration of revising applicable Civil Service Rules & Regulations, Section 111 "Medical Requirements for Firefighters and Police Officers (approved at Civil Service Meeting 4.4.08)", to clarify the timeframe of the testing requirements and who the requirements apply to.
