

**THE CITY OF SAN ANGELO, TEXAS
MINUTE RECORD OF A REGULAR MEETING OF
THE PUBLIC ART COMMISSION**

Following notice and publication, the Public Art Commission convened in a regular meeting at 3:30 p.m., **January 9, 2024** in the Station 618 Office Suite Conference Room, 618 S. Chadbourne St., San Angelo, Texas. **Commission Members Present** were Ryan Dalgliesh, Raul Ruiz, Mark Stevenson, Elaine Stribling and Suzanna Valenzuela. **Staff Members Present** were Mario De La O, Theresa James and Carl White. Guests present were Olivia Perez-Langley, Julie Raymond, Monica Ramos and Kathy Keane. The minutes were recorded by Barbara Stallworth.

I. OPEN SESSION (3:30 P.M.)

A. Call to Order

Mr. Dalgliesh called the meeting to order at 3:30 p.m.

II. CONSENT AGENDA

1. Consider approving the October 31, 2023 minutes. Mr. Dalgliesh motioned to approve the minutes. The motion was seconded by Ms. Stribling and passed unanimously.

III. REGULAR AGENDA: PUBLIC HEARING AND COMMENT

2. Discuss guidelines for considering public art and its placement and recommend any related matters. Ms. James discussed the San Angelo Public Art Commission guidelines and gave examples to answers some specific questions. It was determined that more in depth conversation will be had at the next meeting and Mr. White will make sure each member has a updated copy of the guidelines.

3. Review, discuss and recommend art and its placement of a "Sheep Spectacular" sheep at 135 W. Twohig, sponsored by Congressman August Pfluger. Mr. White showed a presentation of the "Sheep Spectacular" sheep. Mr. Ruiz described the art on the sheep with specific meaning. Ms. Keane discussed the placement of the sheep. Mr. Stevenson motioned to approve the sheep and the placement. Mr. Dalgliesh seconded the motion. The motioned passed unanimously.


4. Discuss and make recommendations on art and its placement for the new pedestrian areas along Chadbourne Street (North Concho River to Beauregard Avenue). Mr. White showed an aerial view of Chadbourne Street. Ms. Raymond and Ms. Perez-Langley discussed the Art in Uncommon Places "Black Tie Cowboy" presentation. The presentation displayed photos of the current locations as well as photos of the area with future projections of displayed art. Mr. Dalgliesh motioned the approval of the project and to be presented to City Council. Ms. Stribling seconded the motion and passed unanimously. Mr. White reminded the group of some details that needed to be completed before sending the idea to City Council.
