## I. Call to order and establish a quorum is present.

The meeting was called to order by the Chairperson at 11:30 AM. A quorum was established by the Chairman.

#### II. Consent calendar:

A. Minutes of the March 21, 2024 meeting

A motion was made by Vice Chair Stacie Elkins, seconded by member Forbes. All present voted aye. Motion passed.

### III. Regular Agenda

A. CA24-03 208 S Oakes Street: a request for a Certificate of Appropriateness for an exterior remodel, window replacement and a new sign on an existing building at 208 S Oakes Street in the Historic Overlay Zone. This is in District #3, Harry Thomas's district and is in the Downtown District.

Chairman Mazur read the application request into the Board record.

Principal Planner Bailey presented the request. The owner of the building has applied for TIRZ funding to replace the front exterior windows with black aluminum framed windows with four panes, and painting the frames. Mr. Stango will also be repainting the doors black, placing lantern lights between the windows, adding a cloth black stripped awning and erecting a eight foot sign in the middle upper space on the building that is matt black and cream white part of the historic color chart. The building itself is small and will become a small pizza restaurant. Discussion followed concerning the color choices for the awning and sign.

The Chair opened the meeting for public comment. None was made. Member Crisp moved to approve the request, member Wehner seconded. All present voted aye. Motion carried.

B. CA 24-04 310 east Washington Drive: a request for a Certificate of Appropriateness for an outdoor classroom structure on the site of the Fort Concho School. Chairman Mazur read the application request into the Board record. Principal Planner Bailey presented the item. The SAISD has requested approval of their open classroom for the Ft. Concho Elementary School. Two sides will have walls but the other two sides will be open. The structure will also have a roof over the classroom area to provide shade and protection from the elements. This area is in District #3, Harry Thomas's district, it is in the Ft. Concho Neighborhood which is in the Historic District Overlay. The applicant has requested a teal color for the beams and support and a darker grey color for the end R panels. The darker grey is closer to the historic colors used at the original time period but the teal is not part of the historic color.

AJ Tuner from the school district and the person in change of erecting this structure came

forward to present to the Board. The structure was started about two years ago. Discussion follows about the appropriate color. The Board referred back to the open structure at the front of the school. Other colors were selected. Chrys Forbes moved to approve the grey selected by the teacher, Stacie Elkins seconded. Staff requested a listing of the exact color: Roy Craft Mist Grey FW2844. The structure frame to be colored. All present voted aye. 5-0 to approve.
