Topic 460: First Aid Kits (Specific Job Contents)

Introduction: A First Aid Kit must be provided on all job sites, and must contain the minimum of supplies as determined by an authorized licensed physician. Employees are required to be informed of the procedures to follow in case of an injury or illness. Trained personnel in possession of a current Red Cross First Aid certificate, or its equivalent, must be immediately available at the job site to provide first aid treatment (if immediate medical response is unavailable). Means to notify Emergency Medical Services must be readily available. Following is a list of recommended contents for First Aid Kits:

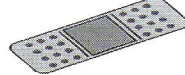

Note: Those who have adverse reactions using latex gloves can use powder-free chloroprene gloves without sacrificing tactile sensitivity.

Remember: The contents of the First Aid Kit must be placed in a weatherproof container with individual sealed packages for each item. The employer is required to check each kit before being sent out on each job, and to ensure that the expended items are replaced in a timely manner. In areas where 911 is not available, the telephone numbers of emergency medical services must be conspicuously posted.
