Such an establishment is thereby considered a legally nonconforming use where alcoholic beverages may again be sold for consumption off these premises.

**DOES NOT COMPLY**

- The subject property does not comply with applicable standards for the sale of alcoholic beverages (to be consumed off-premises) as stipulated in the Zoning Ordinance or elsewhere in the San Angelo Code of Ordinances, and any such sales of alcoholic beverages cannot be considered a legally nonconforming use on this property. Alcoholic beverage sales should not, therefore, be allowed on this subject property.
