Ebert Survey 680, Abstract 0172 (#39 Orient Branch City and SAISD) in San Angelo, Tom Green County, Texas." More specifically, that the designated parties of interest for the appeal alleging error in the determination of the Planning & Development Services Director that "the proposed silica frac sand operation is permitted in the Light Manufacturing zoning district" agree to a hearing date of February 2, 2015, at 1:30 PM, before the Zoning Board of Adjustment.
